






Fig. 3 - Typical Forward Characteristics 10 Forward Current (A)  $T_J=25^{\circ}C$





Fig. 2 - Maximum Non-Repetitive Peak Forward Surge Current 120 100 Peak Forward Surge Current (A) 80 60 40 8.3 ms Single Half Sine-Wave 0 10 100
